WEATHER PROCEDURES

The ALDYB Weather Procedures are our minimum acceptable procedures to deal with the weather at our tournament sites. A local tournament host may have stronger policies in place, but in no instance can they be less than those listed herein.

LIGHTNING

When lightning is detected within 8 miles of the facility, play will be suspended.

No place outside is safe if lightning is in the vicinity. Partially enclosed areas like picnic shelters and dugouts are not safe.

All players, coaches, spectators, officials, etc. will be directed by the public address system to clear the park and go to their vehicles until the lightning threat has ended.

On-field activities will resume after 30 minutes of no detected lightning strikes within an 8-mile radius of the facility.

At any time during the 30-minute delay, subsequent lightning strikes occurring within a 6-mile radius of the facility will restart the 30-minute clock before any on-field activities may be resumed.

TORNADO WATCHES/WARNINGS

A tornado watch is issued by the National Weather Service when weather conditions are favorable for the development of severe thunderstorms that can produce tornadoes.

A tornado watch does not mean that severe weather is occurring, only that atmospheric conditions have created a significant **risk** for it.

If severe weather does occur, a tornado warning would then be issued.

No activities will occur at the tournament site if that location is under a Tornado Watch/Warning.

<u>HEAT</u>

On any day that the local forecast calls for a Heat Index at or above 105°F, there will be a mandatory Heat Break of no less than 5 minutes at the end of every 2 innings of play in every game on that day of tournament play.

This mandatory break should be used to hydrate and rest the participants.

No on-field activities will occur during this time.



- 1. If your team and coaches do not participate in the Opening Ceremonies, the team manager will not be allowed to coach the first bracket game.
- 2. Walk-Up Music—The team coming to bat is allowed to play music but must stop once the third out is made during their turn at bat.
- Tie Game start with a runner on second base. That runner will be the last batter who completed their at-bat of the previous inning.
- 4. Time Limits & Run Rule supersede defensive participation.
- 5. No Time Limit in Championship Game.
- 6. Medallions at the Manager's meeting or first Pool Game.
- 7. No flashes allowed while taking pictures at night.

BATTING CAGE SCHEDULE

Conduct and Sportsmanship

• Members of a team shall not ride, kid, heckle, poke fun at, or in any other way manner, do anything that, in the opinion of the umpire, distracts the opposing team. A player shall not throw a bat, helmet, or other equipment in anger or disgust.

• The penalty for violation of this rule shall be the removal of the guilty player from the game for the remainder of the game.

• The penalty for violation of this rule by a manager or coach shall be his removal from the game and the dugout for the remainder of the game.

• The use of any alcoholic beverage or tobacco products (including vaping devices, e-cigarettes, and cigarettes) Within the confines of the playing field, dugout or bench by any manager, coach, player, umpire or league official is prohibited.

• The penalty for violation of this rule shall be the removal of the guilty manager, coach, player, umpire, or official from the game and the dugout.

• Local leagues have the authority to ban noisemakers during the local league play.

• Local leagues and tournament hosts have the authority, as permitted by local and state law, to remove or ban from the league's playing facilities any spectator who is flagrantly displaying unsportsmanlike conduct, profanity, or who threatens physical harm to umpires, players, managers, coaches, or league officials officials. This authority extends to all scheduled regular-season games or tournament games are played at its playing facilities.

• Tournament directors, at their discretion, may allow the use of noisemakers. However, spectators may not use noisemakers in an attempt to distract the pitcher's delivery of the pitch to the batter. Any such action will be deemed unsportsmanlike conduct and will not be permitted by the umpire. The tournament director may request the tournament host, as permitted by local and state law, to remove from the tournament playing facilities any spectator who fails to discontinue the use of noisemakers after the umpire-in-chief announces their use is prohibited for the remainder of the game.
